ARTICLE III PERMITTED AND PROHIBITED USES

3.01 Restrictive Covenants. The Lots shall be subject to the following protective restrictions, limitations, conditions and agreements:

(t) Rentals. Lots may be rented only in their entirety: no fraction or portion may be rented. No home shall be leased, licensed, or timeshared (to include fractional ownership) for any type of consideration for a period of less than thirty (30) days per renter or occupant, with an exception for lots already providing short term rentals of not less than seven (7) days at a time. Such exception will be contingent on lot owners having registered their properties and having provided a copy of their Manatee County Tourist Tax Registration and a recent rental contract showing daily rentals dated between June 30th, 2021 and October 15th, 2021 to the Association Board of Directors. Such exceptions shall comply with a not less than seven (7) day rental restriction and exception status will expire upon sale or other conveyance of the lot. Donated or auctioned stays at homes in which the owner receives no monetary compensation are required to meet the minimum length of stay requirements, but this does not apply to any stays by the owner or owner's family members. No home shall be rented, leased, licensed or loaned for any type of consideration within twelve (12) months of taking title to a home. Occupancy is limited to three (3) people per bedroom. No short term vacation rental signs are allowed. All leases shall include, or be deemed to include, a statement that all tenants and occupants shall comply with all rules and restrictions of the Association, including, but not limited to, the restrictive covenants of this Section 3.01.
